# **About Six Rivers Dispute Resolution Center:**

Six Rivers Dispute Resolution Center is a non-profit organization committed to fostering peaceful and equitable communities through innovative conflict resolution approaches. As part of our commitment to promoting restorative justice principles, we are launching a pilot program in November 2023- June 2024 aimed at providing alternative dispute resolution services that emphasize healing and community engagement. The pilot program has been in planning over the past year and a half, with input from local systems partners and community members. Six Rivers has a partnership with the New York University Center on Violence and Recovery, and is utilizing the NYUCVR's evidence-informed Circles of Peace model for this pilot program.

## **Position Summary:**

Six Rivers Dispute Resolution Center is seeking a fully licensed Licensed Clinical Social Worker (LCSW), Licensed Marriage and Family Therapist (LMFT), or Licensed Professional Counselor (LPC) in the state of Oregon, as a contracted Clinician for our Restorative Justice Pilot Program. The Clinician will play a vital role in this initiative, working as needed to conduct initial intake assessments and provide therapeutic support throughout the pilot program for youth and adult participants.

## **Key Responsibilities:**

- 1. **Initial Intake Assessments:** Conduct thorough intake assessments with program participants to understand their needs, circumstances, and readiness for participation in the restorative justice process.
- 2. **Therapeutic Support:** Provide individual and group therapeutic services to program participants as needed, utilizing restorative justice principles to help individuals heal and find resolution.
- 3. **Documentation:** Maintain accurate and confidential client records, including progress notes, and assessments, in compliance with ethical and legal standards.
- 4. **Clinical support program:** Help develop and implement a comprehensive clinical support program for volunteers and employees.

#### **Qualifications:**

- Must hold a valid license as a Licensed Clinical Social Worker (LCSW), Licensed Marriage and Family Therapist (LMFT), or Licensed Professional Counselor (LPC) in the state of Oregon. An associate with a clinical supervisor may be considered.
- Strong understanding or willingness to learn about restorative justice principles and practices.
- Excellent communication and interpersonal skills.
- Ability to work independently and as part of a team.
- Commitment to confidentiality and ethical standards.
- History of working with both youth and adults.
- Ideally would have/would be open to having a clinical supervisor (not mandatory).

## **Working Conditions:**

- This is a part-time, grant-funded, contracted, at-will position.
- Flexible hours to accommodate the needs of program participants.
- The Clinician may be required to work occasional evenings/weekends

# **Compensation:**

The Clinician will be compensated at a rate of \$175 per hour depending on experience.
